

RULES GOVERNING THE SUBMISSION AND PROCESSING OF IG1 CREDIT LINE AND REQUIRED RESERVE ALLOCATION

1. IG1 CREDIT LINE ALLOCATION REQUESTED WITH THE MT298 SMT560 SWIFT MESSAGE

As an alternative solution (in the absence of a SWIFT connection), IG1 and required reserve requests may be submitted via a non-SWIFT channel by completing Annex 14 to these Business Terms and Conditions, bearing an electronic signature as set out in Clause 3.8.2, via the electronic channel specified in Sections IV and V of Appendix 2. Following manual processing, the SWIFT messages corresponding to the processing are generated and transmitted via SWIFT. In addition, we shall notify the Interbank Clearing System (ICS) participant eligible for the creation of an IG1 credit line or the credit institution customer that is required to hold reserves by e-mail.

The intraday credit line may be shared between the ICS instant clearing and the ICS night-time clearing (hereinafter referred to as “IG1”).

The intraday credit line unallocated for the IG1 credit line outstanding at the end of the value date serves as the instant credit line (in the case of the institutions that are monetary policy customers).

When the ICS participant authorised to create an IG1 credit line sends an MT298 SMT560 SWIFT message to the MANEHUHBXXX BIC code of the MNB and requests the allocation of the IG1 credit line, the MNB sends an MT298 SMT560 SWIFT reply message on both the receipt and the allocation. Only one allocation shall be accepted each day, and the MNB rejects the messages that arrive after the accepted one and those that are sent after the cut-off time specified in Annexes 2 and 2/a to these Business Terms and Conditions. If no allocation request accepted by the MNB arrives on a given day, no allocation is carried out for that day. In this case the IG1 clearing will be covered by the ICS participant’s account balance and/or minimum balance.

In the case of insufficient collateral, a non-standard method of completion or a credit line allocation request received outside the specified period, the request shall be rejected, and the ICS participant shall be informed in an MT298 SMT560 SWIFT reply message (indicating the reason for rejection in the reference field).

If the ICS participant authorised to create an IG1 credit line submitting the request receives neither a RECEIVED, nor a REJECTED SWIFT message following the submission of its own message, it shall contact the staff of the Domestic Payments department to investigate the problem.

The field has to contain the number 560.

Field 32A: Performance date, Currency code, Amount

The performance date is identical with the day of sending the message.

The amount of the IG1 credit line allocation requested shall be specified in HUF, with a comma after it.

Field 79: Sender receiver information

The first line should contain the code word /IG1LIMIT/.

Field 79: Sender receiver information

Line 1: The code word /IG1LIMIT/ is, in the case of IG1 credit line allocation, followed:

- after the examination of the receipt of the allocation, by the word “RECEIVED” if it has been accepted or “REJECTED” if it has been rejected
- by the word “ACCEPTED” when it is fulfilled, and by the word “REJECTED” when it is rejected.

Line 2: In the case of rejection, the code of the reason for rejection.

The code of the reason for rejection and its meaning may be as follows:

Following the examination of the request received:

FORMAT ERROR: Format error

INVALID VALUE DATE: Wrong value date

INVALID CURRENCY: Wrong currency

INVALID AMOUNT: Amount not in accordance with the standard (e.g. the amount contains fillérs, too)

INVALID CODEWORD: Wrong code word

CUT-OFF TIME: The request for IG1 credit line allocation was sent after the stipulated cut-off time

DUPLICATE MESSAGE: Duplicate received

PROCESS ERROR: The request has already been processed successfully

When fulfilling the request:

INSUFFICIENT FUND: Insufficient collateral

At the end of 2 July 2019, CIB Bank dedicates HUF 10,000,000 for its IG1 credit line from the free collateral value of its collateral pledged for the MNB.

2. REQUIRED RESERVE ALLOCATION FROM THE MIDNIGHT BALANCE OF THE INSTANT CLEARING ACCOUNT REQUESTED WITH AN MT298 SMT 570 SWIFT MESSAGE

Credit institution customers that are required to hold reserves are entitled to initiate an allocation from the midnight balance of their instant clearing account to meet the reserve requirement.

Such credit institutions may initiate the required reserve allocation with an MT298 SMT570 SWIFT message submitted for the MNB's BIC code MANEHUHBXXX. Customers are informed about the receipt, the acceptance or the rejection of the request in an MT298 SMT570 SWIFT reply message, indicating the reason for rejection in the reference field.

Credit institution customers that are required to hold reserves may submit their required reserve request on any VIBER business day in respect of the preceding working day or public holidays. Credit institution customers that are required to hold reserves may submit their request in respect of a specified value date (hereinafter referred to as "single-day request") or in respect of value dates covering several calendar days (hereinafter referred to as "standing request").

A standing request remains valid until the MNB accepts a new single-day or standing request. In the case of value dates specified in a standing request, the MNB will send a reply message even on days when the credit institution customer subject to reserve requirements has not submitted a request.

In case of single-day request

- Only one request may be accepted for any given value date;
- the MNB shall reject any received after the accepted message.

After accepting a standing request, but before the cut-off time deadline, it is possible to submit a new standing request with a modified amount.

The MNB shall reject any messages sent after the cut-off time specified in Annexes 2 and 2/a to these Business Terms and Conditions. No required reserve allocation shall be performed for the value dates for which no single-day or standing request accepted by the MNB is received. If the single-day or standing request contains an allocation amount for a given value date greater than the midnight balance of the instant clearing account, the whole midnight balance of the instant clearing account shall be allocated.

If the credit institution customer that is required to hold reserves submitting the request receives neither a RECEIVED, nor a REJECTED SWIFT message following the submission of its own message, it shall contact the staff of the Domestic Payments department to investigate the problem.

The settlement date is the value date – in the case of a standing request, the first value date – when the midnight balance of the instant clearing account shall be allocated for required reserves. The amount to be allocated for required reserves shall be specified in HUF, with a comma after it.

Field 79: Sender receiver information

The first line should contain the code word /DAILY/ for single-day requests, or the code word /LONG/ for standing requests.

Field 32A: Performance date, Currency code, Amount

The settlement date is the value date – in the case of a standing request, the first value date – when the midnight balance of the instant clearing account shall be allocated for required reserves.

In the case of single-day and standing requests submitted via an alternative solution rather than via SWIFT, the amount allocated on the day of submission; in the case of standing requests, the amount of the request on the days following the day of submission.

Field 79: Sender receiver information

Line 1: The code word /DAILY/ for single-day requests or /LONG/ for standing requests is followed:

- after the examination of the receipt of the required reserve request, by the code word “RECEIVED” if it has been accepted or by the code word or by the code word “REJECTED” if it has been rejected
- by the code word “ACCEPTED” when the required reserve request is fulfilled, by the code word “REJECTED” when the request is rejected and by the code word “PARTIAL ACCEPTANCE” when the request is partially fulfilled – where the midnight balance of the instant clearing account is lower than the amount to be allocated for the required reserve.

The SWIFT message regarding rejection is only sent on the day the request is processed – which, in the case of a weekend clearing day, is the first VIBER business day following that day. If a standing request was in force prior to the rejection, the previous standing request remains valid. If a single-day request was in place prior to the rejected request, no required reserve allocation will take place until the MNB accepts a new single-day or standing request that complies with the standard.

Line 2:

- in the case of rejection, code of the reason for rejection,
- in the case of partial fulfilment, the amount of the partial execution,
- in the case of a fulfilled request not submitted via SWIFT, the amount allocated.

The code of the reason for rejection and its meaning may be as follows:

INVALID VALUE DATE: Wrong value date

INVALID CURRENCY: Wrong currency

INVALID AMOUNT: Amount not in accordance with the standard (e.g. the amount contains fillérs, too)

INVALID CODEWORD: Wrong code word

CUT-OFF TIME: The request for required reserve allocation was sent after the stipulated cut-off time

FORMAT ERROR: Format error

INVALID BIC: Wrong BIC code

PROCESS ERROR: A request for that value date has already been successfully accepted
